## **ATTENTION EXHIBITORS**

The following rules and regulations will be strictly enforced by the show committee, or the Purina Events Center, or both as appropriate.

The show site will be available to exhibitors 12 noon, Wednesday, July 21, 2021.

The show site will be open July 21-25 from 6:00 AM until 10:00 PM. Dogs may be left overnight in the show building. Security guards will be on duty. No one will be allowed in the building between the hours of 10:00 PM and 6:00 AM, unless special permission is granted by the show committee.

Dogs and equipment will need to be removed by 9am on Monday, July 26, 2021

Name and contact information must be left of dog crates in case of emergency.

Private food or drink is not allowed in any Purina facility or competition area.

There will be NO SMOKING (including electronic cigarettes) within the confines of the building.

Sanitary conditions must be maintained in the show building and/or anywhere at the Purina Events Center at all times.

### **PLASTIC AND SHAVINGS WILL BE PROVIDED AND MUST BE USED UNDER ALL X-PENS.**

**Trash pick up will be approx.. every 2 hours, see schedule at show.**

All exercise pens must be identified with the exhibitor's name. Exercise pens must be kept clean. The show committee will monitor the cleanliness of the show building and reserves the right to request grooming areas to be cleaned at any time as deemed necessary. Dogs may not run off lead except in runs or fenced area provided by the Purina Events Center.

Bathing of dogs will be confined to the bathing area provided in the Purina Events Center. It is a privilege to use this area. Please keep it clean.

All dogs in the area around the Obedience and Rally ring must be crated or held on leads. Warm-up practices must be performed on lead.

## PURINA GUIDELINES AND RESTRICTIONS

Purina Farms and the American Spaniel Club have placed the following guidelines and restrictions in place for the 2021 Cocker Spaniel National Specialty and Agility Trial. Anyone planning on attending this event will be required to comply with the following:

### ADMISSION TO THE EVENT AND RESTRICTIONS ON ATTENDANCE

- **Purina Farms has imposed a capacity limit on the facility for this event of no more than 550 total persons in attendance.** In addition, there is a capacity limit of no more than 100 persons on any functions held in Founders Hall, the meeting room on the second level of the Event Center.
- **Because of the capacity limits, Purina Farms requires a complete list of all persons who will be attending this event.**
  - **Any person attending this event for any reason MUST submit their name, address, and contact information (email address and cell number), and whether the attendee is competing in the event, working at the event, or attending in another capacity to the American Spaniel Club.**
  - **Attendees MUST register for this event through the American Spaniel Club event registry system on the club's website, <https://americanspanielclub.org/events-results/july-2021-asc-national-specialty/>**
  - **Attendee information is to be submitted no later than July 11, 2021.**
- **NO ONE WILL BE ADMITTED TO THIS EVENT WHO HAS NOT SUBMITTED THEIR NAME AND OTHER INFORMATION TO THE ASC IN ADVANCE.**

### CHECKING IN TO THE SHOW

- **ALL ATTENDEES ARE REQUIRED TO GO THROUGH A CHECKPOINT AT PURINA FARMS PRIOR TO PARKING, UNLOADING, OR ENTERING THE SHOW SITE EACH DAY OF THE EVENT.**
- At the designated checkpoint, Purina security or staff members will determine whether **ALL** persons in the vehicle are approved attendees by checking names against the master list provided by ASC. **ANYONE IN THE VEHICLE WHOSE NAME IS NOT ON THE LIST WILL NOT BE ALLOWED ENTRANCE.**
- After names are checked, all persons in the vehicle will be asked a few brief questions about their potential exposure to COVID. Once the questions are answered, each person in the vehicle will be given a wristband to wear during that day's event.
- **Attendees must go through the checkpoint each day, have their names checked off, and obtain a new wristband. The wristbands will be color-coded for each day.**
- Once the check-in process is complete, vehicles can be unloaded and parked.
- **Attendees traveling in RVs will be required to check in by 9am each day with a Purina staff person to obtain a new color-coded wristband.** All persons traveling together in an RV will be required to check in.

- **ALL ATTENDEES ARE REQUIRED TO WEAR FACE MASKS AT ALL TIMES WHILE IN THE PURINA EVENT CENTER, EXCEPT WHEN EATING OR DRINKING**
- All attendees are encouraged to provide personal sanitizing supplies, e.g. hand sanitizers, hand-wipes, etc.
- **PURINA STAFF AND SECURITY PERSONNEL WILL MONITOR THE SITE DAILY TO DETERMINE WHETHER CAPACITY LIMITS ARE EXCEEDED DURING THE DAY.**

## **TACK ROOM AND GROOMING**

- **THIS IS NOT A SHOW AND GO EVENT.** However, all attendees should be mindful of the need to keep capacity numbers at a reasonable level, and observe social distancing while in the Purina Event Center.
- Purina has determined all grooming spaces in Gateway Hall will be 5' x 10', separated by a similar sized buffer space between each grooming space. At the club's discretion, the spaces can be reduced in size to 5'x5', if a buffer zone is maintained between grooming spaces.
- **NO FORCED AIR OR STAND DRYERS ARE ALLOWED. Only human type handheld dryers can be used.** The bathing area will be available for use, and ex-pens are allowed in Gateway Hall.
- Seating in the tack room should be contained within grooming spaces and be limited to attendees traveling together or household members.
- Day crating for Agility exhibitors will be allowed adjacent to the Agility ring in the main show arena. However, they must be spaced apart to allow for a buffer between crates and social distancing. If possible, exhibitors who have completed runs for the day are requested to leave the building. Seating should be limited to attendees traveling together or household members.
- Day crating for obedience/rally (if needed) will be located near the obedience/rally rings.

## **SHOW ARENA**

- The conformation, agility and obedience/rally rings will be laid out approximately the same as they have been for previous ASC National Specialty shows.
- Vendors will be located only along one wall to allow for the space between the agility and conformation rings to be used for agility crating. Vendors are encouraged to complete sales through credit/debit cards only.
- Catalog and memorabilia sales tables, and other tables used for fundraising will be allowed, but their space may be adjusted to allow for social distancing and buffer zones. Cash transactions are allowed.
- The conformation ring will include both an entrance and exit gate, with separate tables for stewards, judges and rosettes.

- **Purina/ASC will not be providing chairs for ringside seating.** Anyone attending the show who wishes to sit at ringside may do so, but must use their own chairs. Social distancing is required, and seating will only be permitted in areas designated by Purina. Standing at ringside is also permitted, if social distancing is maintained.
- **Reserved patron seating will be allowed with chairs to be provided by ASC.**
- A limited number of chairs will be provided by Purina for judges, stewards, the videographer and other show workers. Judges' education seating will be provided as needed.
- Agility equipment should be handled by as few people as possible to prevent the spread of any contaminants. Social distancing is also requested as much as possible during walk-throughs and course discussions.

#### **PHOTOGRAPHER/VIDEOGRAPHER**

- Social distancing is required at the photo setup.
- Show Dog Video Pros will have tables and chairs for their use only at ringside.

#### **FOOD/DRINK AND RESTROOMS**

- The Café will be open with individually wrapped food items available. Seating will be limited in the Café with a capacity of no more than 25 people. Masks are to be worn in the Café, except when actually consuming food and beverages.
- Attendees are encouraged to consume food and beverages in the grooming/crating areas. Please observe the guidelines on wearing masks except when actually eating or drinking.
- **SEATING AT TABLES IN THE CAFÉ AND OTHER EVENTS IS RESTRICTED TO HOUSEHOLD MEMBERS OR PEOPLE TRAVELING TOGETHER.**
- **Special events in the Founders Room (upstairs) have a limited capacity of no more than 100 people. Banquets are allowed, but food items must be individually boxed. No bars or alcohol are permitted.**
- Attendees may only use restrooms on the main floor of the Purina Event Center. Restrooms on the upper level are restricted for use by Purina staff only.

These guidelines and restrictions are subject to change at any time prior to the ASC National Specialty Show and Agility Trial.

# AKC Code of Sportsmanship

*PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.*

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.
