## MEMBERSHIP APPLICATION PROCESS AND DUES SCHEDULE FOR NEW APPLICANTS

APPLICATIONS MUST BE RECEIVED BY FEBRUARY 1 FOR APRIL ELECTION, BY MAY 1 FOR JULY ELECTION, BY AUGUST 1 FOR OCTOBER ELECTION, BY NOVEMBER 1 FOR JANUARY ELECTION

### A) DUES SCHEDULE FOR NEW APPLICANTS

\$160.00 - Household\* (\$90.00 non-refundable initiation fee\*\* plus \$70.00 annual dues)

*\*Household is defined as TWO adult members living at the same residence.*

*\*\*\$90.00 represents the \$45.00 non-refundable initiation fee for each of the two applicants.*

\$85.00 - Individual (\$45.00 non-refundable initiation fee plus \$40.00 annual dues)

\$60.00 - Junior (under 18) (\$45.00 non-refundable initiation fee plus \$15.00 annual dues)

\$20.00 - Associate (non-voting) (\$20.00 annual dues – No initiation fee)

Note to Foreign Applicants: Applicants residing outside of the United States are assessed a yearly mailing surcharge as follows:

Canadian and Mexican Applicants - \$5.00; All other Foreign Applicants - \$10.00

### B) APPLICATION PROCESS

1. Please complete ALL parts of the application form, including your nine-digit zip code. Any two people applying together as a household must complete individual application forms.
2. Before mailing your application, use the following checklist to be sure you have included ALL of the following:

☐ **Completed Application Form(s)**

☐ **Sponsorship endorsement from two ASC members**

Your application must be sponsored by two members of the American Spaniel Club. Select two (2) members of the A.S.C. who are most familiar with your interests and activities in dogs to sponsor your application. Have your sponsors complete the SPONSOR ENDORSEMENT OF APPLICANT FOR MEMBERSHIP form and return it to you. (NOTE: Sponsors may endorse household applicants on one form.)

#### **DEFINITION OF SPONSOR:**

a) a member in good standing of A.S.C.

b) an individual who has known you for at least six (6) months.

c) sponsors cannot be members of the same household or members of the applicant's household.

☐ **Signature of your Zone Director** (Listing of Zones and Directors enclosed) In case of Foreign Applicants, the President's signature is required.

☐ **Signed Code of Ethics Card(s)** (Card enclosed)

☐ **Payment in U.S. Funds**

For membership dues and initiation fees including mailing surcharges (if applicable), acceptable payments are 1) Checks drawn on U.S. Banks, 2) U.S. Money Orders or 3) Canadian Money Orders for U.S. Funds. Checks on foreign bank for U.S. Funds are NOT acceptable. If you would like to pay by credit card, complete the information below and send to the ASC Membership Chair.

The Board of Directors will review all concerns and objections prior to voting on your application.
